Initial Here	2 The owner or agent of any real property registered with the Town shall update the information on this application within thirty (30) days after any change in such required information regardless of whether the information provided to the registry was in the deed under power of sale or deed in lieu of foreclosure. Sec. 26-104
Initial Here	3. The owner or agent of any vacant or foreclosed real property registered with the Town may apply to remove the property from the registry at such time as the property no longer constitutes vacant or foreclosed real property. These requests must be made to the Town Manager in writing. Sec. 26-105
Initial Here	4. Failure to register vacant or foreclosed real property or failure to update the information specified in paragraphs (1) through (5) of subsection (c) of Section 26-102 shall be punishable by a fine of up to \$1,000.00.
